

Quick Reference Guide: Disenrolling a Provider from Ohio Medicaid

Steps: **These steps should only be completed as a request to withdraw a provider's enrollment with Ohio Medicaid; meaning the Medicaid ID assigned to the provider will no longer be active.*

1 *Note: If a disenrollment needs to be completed to change a behavioral health provider type (Ex. Changing from a Paraprofessional (96) to a Social Worker (37)), these steps would also be followed. In this scenario, once the disenrollment is processed, a new enrollment under the 'new' provider type can begin.*

Click on the Reg ID or Provider name hyperlink of the provider that is disenrolling from Ohio Medicaid.

This process can be completed by the Administrator for the Medicaid ID being converted or a user with the Agent role, if that Agent has been assigned the 'Enrollment Agent' action by the Administrator.

A disenrollment request is sent to Ohio Department of Medicaid (ODM) Enrollment to process.

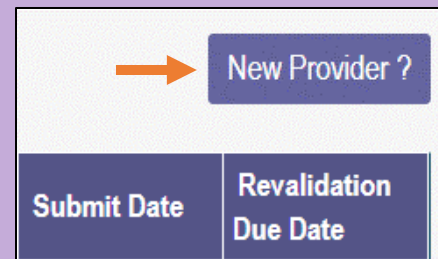
Once the disenrollment has been processed, the status for the provider on the dashboard will update and show 'Disenrolled.'
