

Quick Reference Guide: Accessing MCO Network Adequacy Reports

Steps:

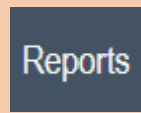
- Go to https://ohpnm.omes.maximus.com/OH_PNM_PROD/Account/Login.aspx and click **Log in with OH|ID**.

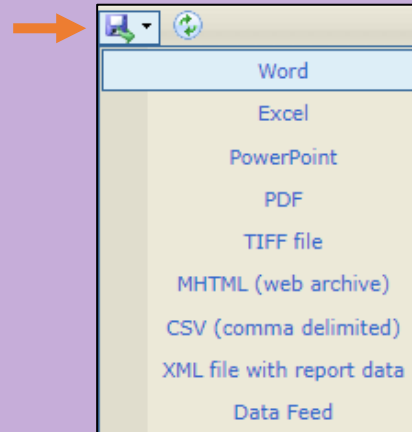

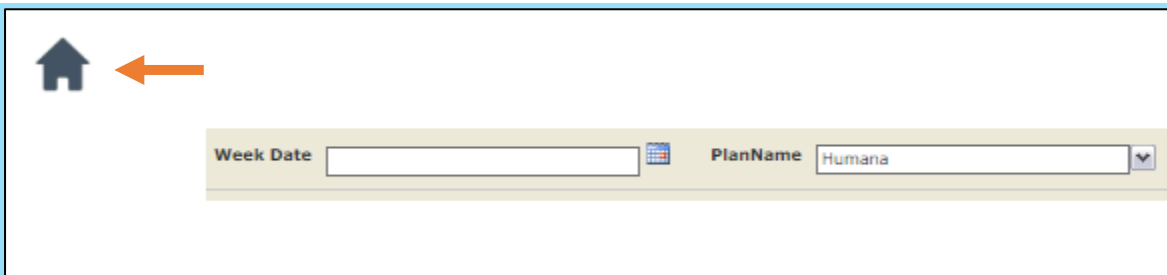

- View the report within PNM.
- To export the selected report, click on the 'disk' icon and choose the export format from the list provided (ex. Excel).
 - The document will download to the designated download folder for your browser. Locate that folder on your computer to open the downloaded document.

- Within the same report, you can select the dates. Once the selection is made, click on View Report to see both Summary and Detail reports.
- For Ohio Rise reports only, the user will select a 'To' and 'From' Date Range.
- *Note: Both Summary and Detail reports are available for the current week. However, historic reports are only available to view and download for Detail reports.*
- To view a different report, click the home icon at the top of the page and repeat Steps 2-5.

Requesting Report Roles in PNM

- Access to the reports and provider data:
 - Read Only
 - MCP Report Role
- Access to reports, provider data and eligibility look up:
 - Read Only
 - MCP Report Role
 - County Court

**These are internal user roles.*

A single user account (OH|ID) can either be an internal user account or a provider user account, but not both. For example, users cannot hold the MCP Report Role (internal user) and a Provider Administrator role (provider user) under the same OH|ID account.

A 'Y' in the column indicates that the report is available to the user/MCO role listed.

An 'N' in the column indicates that report is not accessible by a user with that role.
